This is to notify that the Vice Chancellor has been pleased to fix 7th May, 2021 at 11.30 A.M. in the Academic Council Hall of the Utkal University as the date, hour and place respectively for the poll for election of two members to the Syndicate under Clause-(j) of sub-section-(1) of section-(10)(a) of the Odisha Universities (Amendment) Act, 2020.

1. The number of vacancies under clause-(j) of sub-section (1) of Section-10 (a) of the Odisha Universities (Amendment) Act, 2020. = two
2. Each elector of the Academic Council is entitled to nominate two members to the Syndicate in the prescribed form.
Any person shall be disqualified (vide Section 30 of the Odisha Universities Act, 1989) for election, nomination or selection as member of any of the authorities of the University, if he/she:-
 - (a) is at the date of election, nomination or selection of unsound mind or deaf mute; or
 - (b) is an uncertified bankrupt or un-discharged insolvent; or
 - (c) has been convicted of and sentenced by a criminal court to imprisonment for an offence involving moral turpitude; or
 - (d) is being elected, nominated or selected consecutively for a second term.Explanation- For the purpose of this clause the expression "term" shall include "part of a term".
3. The copy of the prescribed form for nomination and prescribed form for submission of statement of the nominee is available with the Section Officer, Syndicate Section of the Utkal University, which may be obtained in writing on a plain paper by each of the electors for the purpose. Any problem with regard to the receipt of above papers may be brought to the notice of the undersigned in writing at once. The electoral roll will be available with the Section Officer, Syndicate Section for reference.
4. Nomination forms will be issued from 16.04.2021 to 30.04.2021 from 11.00 A.M. to 3.00 P.M. on all working days.
5. All nominations should reach the Registrar, Utkal University, Vani Vihar, Bhubaneswar-4 not later than 30.04.2021 by 03.00 p.m.

Note- In order to ensure safe delivery of nomination papers, it should preferably be submitted either in person or through special messenger in a sealed cover superscribed "Nomination paper for Syndicate (Academic Council constituency)" to the Registrar on any working day of the University office during office hours by the date and time fixed.

6. The scrutiny of the nomination papers will be made by the Deputy Registrar (General) on 30.04.2021 at 4.00 P.M. in the Academic Council Hall till its completion.
7. The date of Notification for valid nomination will be on 03.05.2021 at 11.00 A.M.
8. The date of withdrawal of nomination paper will be on 04.05.2021 by 02.00 P.M. and notification of valid nomination after withdrawal will be on 04.05.2021 by 04.00 P.M.
9. The candidate or his/her representative duly authorized by him/her is entitled to be present at the time of scrutiny.
10. The polling, if necessary, will be made in the Academic Council Hall of the Utkal University, Vani Vihar, Bhubaneswar-4 on the 7th May, 2021, from 11.30 A.M. to 01.30 P.M.
