It is hereby notified for information of all concerned that on recommendation of the Equivalence Committee held on 17.02.2017 and the Vice- Chancellor in exercising of his power under Section 6 (15) of the Odisha Universities ACT, 1989, has approved on 23.03.2017 and recognised the degrees of the following Universities/Institutions as equivalent with the course of Utkal University as stated below, which requires subsequent ratification by the Academic Council of Utkal University at its meeting Scheduled to 19.04.2017.

Sl. No	Name of the Universities / Institutions	Equivalent to Utkal University
1	Equivalency of Hindi Pandit Course with Hindi B.Ed.	As per recommendation of SCERT the Hindi Pandit Training Course of Andra Pradesh is equivalent with the BH.Ed. course only for the year 2013-14 and 2014-15.
2	Equivalency of B.A.,B.Ed. & M.A. Course of Moulana Aazd National Urdu University with the corresponding course of Utkal University,	As it is a Central University stand recognised by Utkal University and Equivalence is granted.
3	Equivalency of Moallim-E- Urdu Course of Jamia Urdu Aligarh, U.P., with the corresponding Course of Utkal University,	In view of the recognition of NCTE and recognition of Govt. Of India B,Ed. Urdu degree of Jamia Urdu Aligarh, U.P. is recognised for the purpose of employment as teachers upto Secondary standard and it may be noted that at present Utkal University is not offering Urdu B.Ed..
4	Equivalency of B.Ed. and M.Ed. Course of Adikabi Nannaya University, Rajahmundry(A.P), with the corresponding Course of Utkal University	Equivalency of B.Ed. and M.Ed. Course of Adikabi Nannaya University, Rajahmundry (A.P), with the corresponding Course of Utkal University is accepted.
